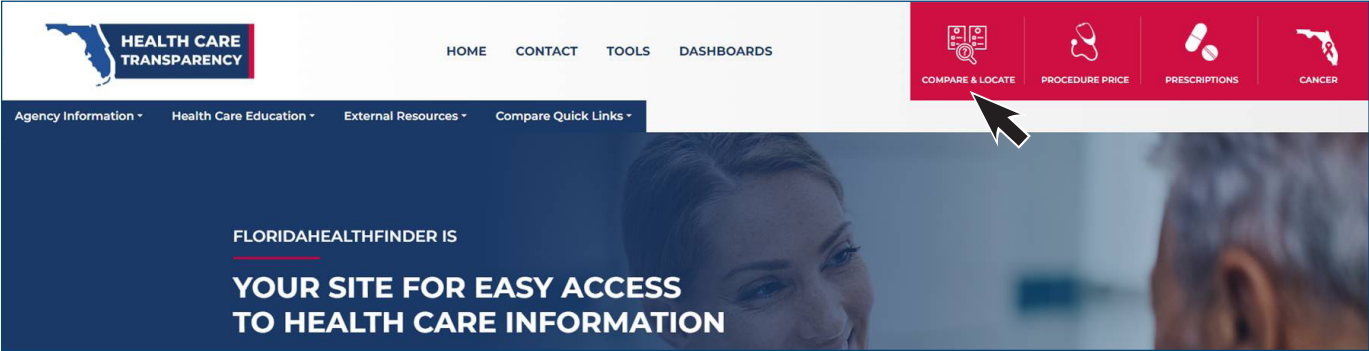


# How to Select a Drug-Free Workplace Testing Lab

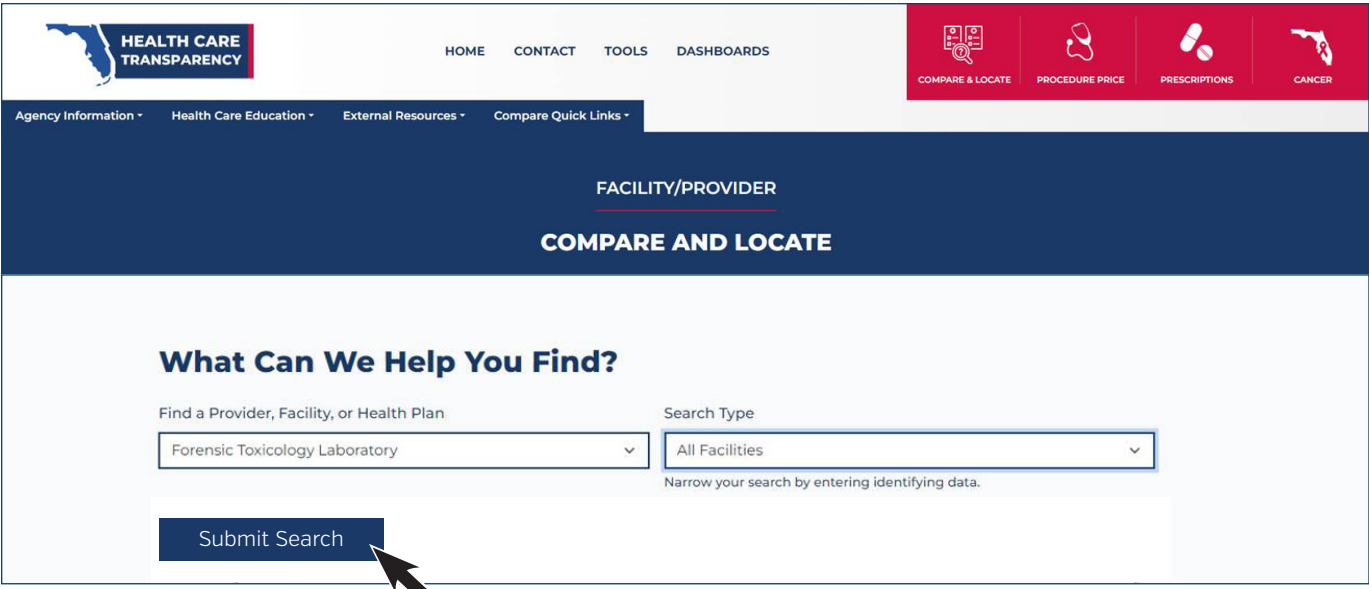
## For Florida

To be eligible for a drug-free workplace program premium credit, a testing lab licensed by the Agency for Health Care Administration [AHCA] for Florida must be included in your premium credit application. Here are instructions for selecting a testing lab through AHCA.

- 1 Visit the Florida Agency for Health Care Administration website at <https://quality.healthfinder.fl.gov/> or by [clicking here](#).
- 2 Click on **Compare & Locate** at the top of page.



- 3 On the next page, go to **Find a Provider, Facility or Health Plan** and select **Forensic Toxicology Laboratory** from the drop-down menu. Select **All Facilities** for the **Search Type** and click on **Submit Search**.
