


How to Select a Drug-Free Workplace Testing Lab


For Florida

To be eligible for a drug-free workplace program premium credit, a testing lab licensed by the Agency for Health Care Administration (AHCA) for Florida must be included in your premium credit application. Here are instructions for selecting a testing lab through AHCA.

- 1 Visit the Florida Agency for Health Care Administration website at https://quality.healthfinder.fl.gov/ or by clicking here.
- 2 Click on Compare & Locate at the top of page.



3 On the next page, go to **Find a Provider, Facility or Health Plan** and select **Forensic Toxicology Laboratory** from the drop-down menu. Select **All Facilities** for the **Search Type** and click on **Submit Search**.



4 The next page will provide directions on Advanced Search Options and the results of your search. Scroll down the page to view a list of approved laboratories and contact information based on your search (similar to below).
